■ CPR (Article 96(3))

➤ ...an OP shall describe the integrated approach to territorial development(..), specifying, **where appropriate**, the following:

➤ (d) the arrangements for interregional [and transnational] actions, within the OPs, with beneficiaries located in at least one other Member State
(Section 4.4)

➤ (e) the contribution of the planned interventions under the programme to MRS/SBS strategies (Section 4.5)

2021-2027

■ CPR Article 22 (3)

➤ Each programme shall set out:

➤ (a) a summary of main challenges

➤ (viii) MRS/SBS

➤ (d) **for each specific objective:**

➤ (i) related types of action + expected contribution to those SOs and to MRS/SBS, where appropriate

➤ (vi) the interregional and transnational actions with beneficiaries located in at least one other Member State or outside the Union, where relevant

■ CPR Article 5 and 6: Thematic Concentration 30% of ERDF and 37% CF to Climate Objectives



How to boost the Embedding process at programme level?

Specific selection criteria (e.g. bonus points)

Earmarking of a dedicated allocation – strategic project within the OP

Specific calls for FLAGHIP projects (like ADRION 14-20:

Ex-ante or ex-post labelling (for communication purpose only)



The Embedding process at programme level – implementation in practice

Joint projects: contributions to a single "pot" to fund a single project.. (**possible only with centralised funds from the commission**)

Single project: Projects implemented in a single Member State contributing to the jointly agreed priorities of a macro-regional and/ or sea-basin strategy (**EISF and Cohesion funds at the country level**)

Complementary projects: One programme funds one part and a second one another part. (**Interreg plays the linking essential role!**)

Coordinated projects: Separate nationally/ regionally implemented projects to achieve commonly agreed joint objectives ("cumulative effect") on the basis of coordinated and if possible synchronised decisions. (**Maybe next programming period...**)

Purpose of the Flagships projects

To enable the **translation of macro-regional** priorities to the national/cross-border level and to understand the “conglomerate” of emblematic actions and steering this action in **one common direction**.

To elaborate the priorities based on the **feedback from the countries** and form them into flagships, to show the contribution of specific actions to establish the coordination between EUSAIR Countries in line with the Catania Declaration of 2018 and the 2019 Portorož EUSAIR Financial dialogue between ESIF/IPA Programme Authorities and key implementers of the EUSAIR on how **to build synergies and embed relevant EUSAIR priorities into the ESIF/IPA programmes**.

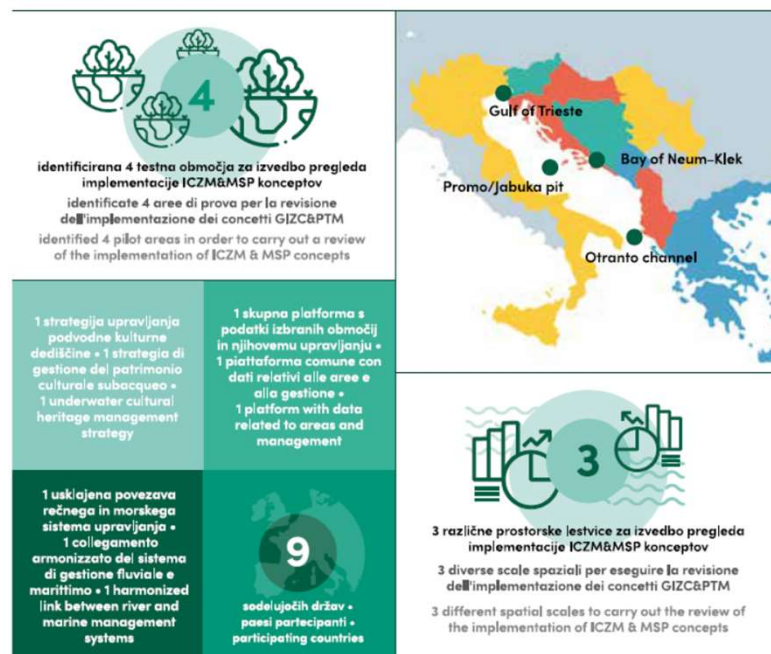

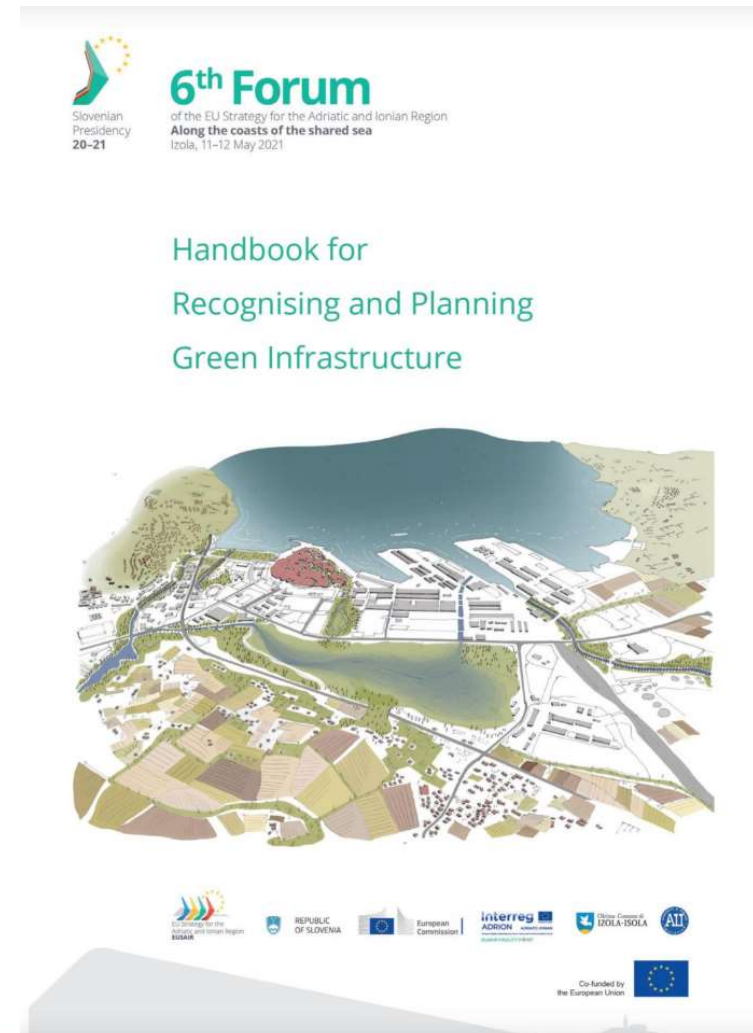
